Governor DeSantis,

First I wanted to say thank you for protecting the Constitutional Rights of We the People here in Florida.

My request is to meet with you as soon as possible to discuss executive action you need to take as the Governor for the future of the State of Florida that can have a positive impact on the State of Florida when you are no longer Governor in the event we have a tyrant in your position someday.

The following issues are some of the agenda I would like to discuss with you:

I have attached a CEASE and DESIST NOTICE to put the State and federal government on NOTICE as to the communist criminal activity being perpetrated against We the People by State and federal Officers as legislators and judges and I know you are trying to protect We the People as well.

As I mentioned I appreciate your stand against the corruption at the federal level but ask that you veto ALL unconstitutional legislation **such as** the violation by the Florida legislators attempting such communist unconstitutional legislation to impede Constitutional Carry.

The **Preamble to the Bill of Rights** was very clear that ALL 10 Amendments are RIGHTS and not suggestions and I suggest you send the CEASE and DESIT NOTICE to the State legislators for their misconstruction and abuse of the power of the Constitution of and for the United States of America.

"THE Conventions of a number of the States, **having at the time of their adopting the Constitution**, expressed a desire, **in order to prevent misconstruction or abuse of its powers, that further declaratory and restrictive clauses should be added**: And as extending the ground of public confidence in the Government, will best ensure the beneficent ends of its institution." (Emphasis added)

Bill of Rights - Second Amendment

"A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, **shall not be infringed**." (Emphasis added)

As the Governor of Florida you must veto the part of the Constitution of the State of Florida under Article 1 Section 8 - Declaration of Rights **"except that the manner of bearing arms may be regulated by law."**

The States had already declared that the Bill of Rights were to prevent misconstruction or abuse of the powers of the Constitution so the State of Florida has NO AUTHORITY to make any law to restrict We the People to be armed without limitation. The Militia is We the People and is to

protect against tyrannical rule like the Florida State legislators are attempting.

To further my point the Constitution of and for the United States of America is the SUPREME LAW OF THE LAND that is a CONTRACT between We the People and anyone receiving tax dollars of We the People as compensation as the following clauses validate:

Preamble to the Constitution of and for the United States of America

"We the People of the United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defence, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America." (Emphasis added)

Article. VI. – Debts, Supremacy, Oaths

*"This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, **shall be the supreme Law of the Land**; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding."* (Emphasis added)

Article. VI. – Debts, Supremacy, Oaths

*"The Senators and Representatives before mentioned, **and the Members of the several State Legislatures, and all executive and judicial Officers, both of the United States and of the several States,** shall be bound by Oath or Affirmation, to support this Constitution;"* (Emphasis added)

Article 1 – The Legislative Branch

Section 10 – Powers prohibited of States

"No State shall enter into any Treaty, Alliance, or Confederation; grant Letters of Marque and Reprisal; coin Money; emit Bills of Credit; make any Thing but gold and silver Coin a Tender in Payment of Debts; pass any Bill of Attainder, ex post facto Law, **or Law impairing the Obligation of Contracts,** or grant any Title of Nobility." (Emphasis added)

To further prove my point may I also remind you that as the Governor you have the authorization to use the Militia to enforce the LAW under the Constitution of the State of Florida under Article 4 Executive Section 1 - Governor:

"(d) The governor shall have power to call out the militia to preserve the public peace, execute the laws of the state, suppress insurrection, or repel invasion."

Under the Constitution of the State of Florida under Article 1 Section 7 - Military Power - the military power is subordinate to the civil or Militia power:

"The military power shall be subordinate to the civil."

The Constitution of and for the United States of America is very clear Congress is required to call forth the Militia to be governed by the States under Article 1 Section 8 - Powers of Congress:

*"To provide for calling forth the Militia to **execute the Laws of the Union, suppress Insurrections and repel Invasions;***

To provide for organizing, arming, and disciplining the Militia, and for governing such Part of them as may be employed in the Service of the United States, reserving to the States respectively, the Appointment of the Officers, and the Authority of training the Militia according to the discipline prescribed by Congress;" (Emphasis added)

To share personally how ridiculous the State and federal legislators are about unconstitutional legislation to restrict LAWFUL FIREARM OWNERSHIP I had a brother killed by a drunk driver and alcohol and vehicles have caused more deaths than any firearm but I am not advocating for the abolition of vehicles or alcohol because it was neither of those that killed my brother it was the irresponsible person that killed my brother.

Under the State and federal legislators ridiculous logic they should be banning alcohol and vehicles.
