Hello Julie,

Thank you for your kindness today on the phone.

Please find attached the letter I sent to U.S. Representative Kelly dated 8-21-19 detailing the corruption at the local, state and federal level. the timeline of events can be read and downloaded at www.1776ToTyranny.com about half way down the Home page.

Please visit www.1776ToTyranny.com and review the Exhibit List for the 300 page document detailing all the evidence I sent to then U.S. Attorney General Ashcroft as well as many in congress and agencies such as the FBI yet NO ONE DID ANYTHING!

The following main points and ALL evidence can be downloaded at www.1776ToTyranny.com:

- Exhibit 11 is the letter dated 3-21-01 that I sent to then AK Steel CEO as well as those at the Butler plant warning AK Steel of the retaliatory discipline as well as detailing how they were violating the law forcing workers to violate their own written policy and public policy.
- Exhibit 20 is the letter from Bill Gonce AK Steel Industrial Relations Manager dated 6-19-01 where he lies and states "The grievant violated Company rules and policy and demonstrated insubordinate behavior." when IN FACT I have provided evidence upon evidence on the website that I followed AK Steel written policy yet they fired me anyway!
- Exhibit 28 is a letter dated 11-29-01 that I sent to then Butler County Tim McCune of the criminal activity and Exhibit 31 is the response letter dated 12-19-01 to me from McCune in which he ignored my evidence. I provided parts of the U.S. Code that was violated and AGAIN McCune did NOTHING! In a phone conversation I had with McCune after he sent me the letter he said unless there was a fatality he was not going to do an investigation and then about a year after I was fired Keith Eckenrode was killed and McCune did NOTHING!

Senator Rubio in Florida has initiated a congressional inquiry with the U.S. Justice Department and I would ask for Representative Kelly to make sure that my Constitutional Right to a TRIAL BY JURY is upheld as I recently refiled a Complaint in May of this year. The Complaint and all court filings since then can be read and downloaded on the website as well.

I am a strict Constitutionalist and what happened to my family and I was why the Founders and Framers created the Constitution to protect We The People from happening. AK Steel, Union, attorneys, McCune, government agencies and those that I sent the letter in 2003 to congress all have committed crimes and if you look at the true definition of sedition all those involved have violated the Supreme Law of the land which is the United States Constitution by denying my right to a trail by a jury of my peers years ago as well as all my RIGHTS under the United States Constitution and is why I refiled my Complaint this year.
