

PETITION to Abolish the Federal Reserve!

My signature below is my authorization to PETITION & DEMAND that Congress ABOLISH the UNCONSTITUTIONAL Federal Reserve! Congress gave the monopoly of our monetary system to a private banking cartel under the 1913 Federal Reserve Act to enslave WE THE PEOPLE with a debt based economy & national debt that can never be repaid.

This PETITION is given to Congress because the duty & power of WE THE PEOPLE is derived from the Declaration of Independence "...That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, — That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it..."

CURRENCY (paper money that is LEGAL tender for paying debts) derives its VALUE from goods & services and is more stable and CANNOT BE MANIPULATED when backed by real money (gold and/or silver)!

Under the Federal Reserve we have FIAT CURRENCY which is UNCONSTITUTIONAL paper money backed by NOTHING that causes our boom and bust cycles! Fiat Currency is UNCONSTITUTIONAL & NOT LEGAL TENDER!

Below are just a few facts as to WHY the Federal Reserve MUST be abolished:

- *A \$20 bill (actually \$20.67) was worth 1 ounce of gold from 1834 to 1933. If you took a 1 ounce gold coin OR a \$20 bill to a fine clothing store in 1910 you could purchase a very nice suit and today you could purchase a very nice suit with a 1 ounce gold coin but you CANNOT do the same thing with a \$20 bill today!*
- *In 1970 a \$1 Bill could purchase 10 candy bars but today you cannot even purchase 1 candy bar the same size as could be purchased back then – which means loss of purchasing power!*
- *The Federal Reserve Act permitted the banks to use fractional reserve lending (loaning money they do not have) which is just a nice way to say COUNTERFEITING! If WE THE People were to print money we would be arrested & put in jail!*
- *The act of abolishing the Federal Reserve will extinguish the majority of our national debt since WE THE PEOPLE are taxed to pay interest to the Federal Reserve just for printing currency! Basically we rent our currency from the Federal Reserve that was OUR monetary system prior to 1913!*
- *The act of abolishing the Federal Reserve means we will have no need for the IRS either!*
- *Before the Federal Reserve the US Treasury circulated money back by gold but we were UNCONSTITUTIONALLY removed from the gold standard in 1971 which removed all checks & balances from just printing money which has devalued the \$1 by 92% since 1913 which is theft of the WE THE PEOPLE!*
- *The banks & Wall Street created the meltdown of 2008 & the average person lost the majority of the value in their 401k's, 403b's or any financial vehicle tied to Wall Street yet CONGRESS bailed out the banks & Wall Street from the tax dollars from those that lost in the stock market & the rest of American people! The reality is CONGRESS STOLE OUR tax dollars to give to those that caused the 2008 crash!*
