Thank you very much for taking the time to read my correspondence of evidence at the local, state and federal level perpetrated against my family and I.

The reason for my email is to seek your assistance in calling for a Congressional Hearing and investigation regarding the corruption my family and I have dealt with for the past 20 plus years. Senator Rubio and Congressman Rutherford have started a Congressional Inquiry regarding the corruption against me. Senator Rubio received a letter from Calvin A. Shivers, Deputy Assistant Director of the Criminal Investigative Division (on my website) and I have since sent my "Appellant's Brief" to the Jacksonville Florida FBI Field Office but in light of the recent revelations about General Flynn's experience with the FBI is why I am reaching out to you to hold our elected and appointed officials accountable.

May I remind all the elected and appointed officials of the words of Justice Brandeis as he eloquently affirmed his condemnation of abuses practiced by Government officials in the case of *Olmstead vs. U.S.* 277 US 438, 48 S.Ct. 564, 575; 72 L ED 944 (1928) he declared:

"Decency, security, and liberty alike demand that Government officials shall be subjected to the same rules of conduct that are commands to the Citizen. In a Government of laws, existence of the Government will be imperiled if it fails to observe the law scrupulously. Our Government is the potent, the omnipresent teacher.

For good or for ill, it teaches the whole people by its example. Crime is contagious. If the Government becomes a law-breaker, it breeds contempt for law; it invites every man to become a law unto himself. It invites anarchy. To declare that, in the administration of the law, the end justifies the means would bring a terrible retribution. Against that pernicious doctrine, this Court should resolutely set its face."
